



## **A Fair Trade Breakthrough: The T.R.A.D.E. Act**

On Wednesday, over 50 Members of Congress, including Representatives Al Green (D-9) and Gene Green (D-29), introduced a new bill that lays out a fair trade agenda for the future. The bill was spearheaded by Rep. Mike Michaud (D-ME) and Sen. Sherrod Brown (D-OH).

The TRADE Act (Trade Reform, Accountability, Development, and Employment) lays out a framework for how we can turn our free trade policies into fair trade policies, and how we can create a more democratic, just approach to globalization.

Specifically, the TRADE Act:

- \* Requires a review of existing trade pacts, including the North American Free Trade Agreement (NAFTA), the World Trade Organization (WTO) and other major pacts.
- \* Sets forth what must and must not be included in future trade pacts.
- \* Provides for the renegotiation of existing trade agreements.
- \* Describes the key elements of a new trade negotiating and approval mechanism to replace Fast Track that would enhance the role of Congress and the public in crafting trade agreements that can meet the needs of workers, family farmers, and the environment.

For a long time, we have had one battle after another trying to defeat harmful free trade agreements. From NAFTA to CAFTA, we have had to make a case for why we are against these agreements. Starting today, we can make the case for what we are for. The T.R.A.D.E. Act lays out a vision that all types of groups can get behind. This Act is strongly supported by the Texas Fair Trade Coalition, the Citizens Trade Campaign, and 20 different union, environmental, consumer, family farm, and faith groups.
